

## Robinhood Feed Terms of Service

The following terms and conditions (the "Terms") govern all use of Robinhood Feed (the "Service"), which is offered by Robinhood Crypto, LLC through the Robinhood Platform. The Service includes and makes available certain content (the "Content") allowing for real-time communication among Robinhood Crypto customers. When used in these Terms, the words "I", "Me", or "My" mean the owner of the account with Robinhood Crypto. By using the Service, I accept these Terms and will be legally bound by them. The Terms are in addition to any other agreements with Robinhood Crypto, LLC, its parent Robinhood Markets, Inc., or any affiliates (collectively "Robinhood"). If I do not agree to the Terms, I must not use or access Robinhood Feed, and must submit a request at <https://support.robinhood.com> to inform Robinhood. Continued use of the Service following the posting of any changes to these Terms constitutes acceptance of those changes and I am responsible for reviewing those terms.

**1. Disclaimer.** The Content and the Service are provided for informational purposes only, and are provided on an "as is" and "as available" basis. Robinhood does not guarantee the accuracy, timeliness, completeness or usefulness of any Content. I agree to use the Content and the Service only at my own risk. Robinhood does not explicitly or implicitly endorse or approve any third-party Content.

**2. No Recommendation or Investment Advice.** The Content is not intended to provide financial, legal, tax or investment advice or recommendations. **6. Consent.** By using the Service or the Content, I consent to recording and retention of any communication, information and data exchanged between you and Robinhood. All communications made at or through the Service should be considered public. Robinhood does not screen, review, approve or endorse any Content available on or through the Service. Reliance on any such Content is at your own risk. As part of providing you the Service, Robinhood may need to provide you with certain communications, such as service announcements and administrative messages.
